



FEIN manufacturer's declaration of limited warranty for the United States of America.

LIMITED WARRANTY

STANDARD WARRANTY - ONE YEAR

For a period of one (1) year from delivery, FEIN Power Tools Inc. warrants to the original purchaser that the FEIN product purchased is free from defects in material and workmanship and agrees to repair or replace, at its option, any defective product or part of product. If a product replacement is appropriate hereunder, FEIN Power Tools Inc. may, at its option, replace a warranted product with the closest successor product. This warranty is non-transferable and does not apply to products which, after our inspection, are determined to have been damaged due to neglect, abuse, overloading, operation with incompatible voltages or types of electricity, accident or improper usage. You must pay all shipping and handling charges.

FEIN POWER TOOLS INC. MAKES NO WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE AND MAKES NO OTHER WARRANTY, EXPRESS OR IMPLIED, BEYOND THE WARRANTY EXPRESSLY SET FORTH ABOVE. ALL INCIDENTAL AND CONSEQUENTIAL DAMAGES ARE HEREBY EXPRESSLY EXCLUDED. Your remedy for breach of warranty hereunder shall be limited to repair or replacement of non-conforming parts and machines. Some states do not allow exclusions of certain warranties and/or damages, so the above limitations may not apply to you.

HOW TO OBTAIN SERVICE: You should retain your original receipt and store it in a safe place as proof of purchase. If service under this warranty is required, please first review the instruction manual carefully to make sure your use is consistent with the instruction manual, then call your authorized dealer. If your authorized dealer cannot provide the necessary service, then write or phone us (Monday through Friday, 9:00 a.m. ? 5:00 p.m. Eastern Time, holidays excluded) to tell us exactly what difficulty has been experienced. If service is required under this warranty, you will need to return the product to FEIN Power Tools Inc. at the address set forth below and provide the model and serial number of your product along with a copy of your original sales receipt (indicating the original date of purchase) to obtain service. Partially or completely disassembled power tools will not be accepted.

EXTENDED WARRANTY - 3 YEAR FEIN PLUS WARRANTY

In addition to our standard one year warranty, you may extend warranty coverage for an additional two years (three years from delivery, in total) for any FEIN power tool product purchased after September 1, 2005 (except for Fein high-frequency power tools, FEIN accu tec screw guns, FEIN balancers, FEIN vacuums, FEIN routers, FEIN pipe processing tools, FEIN compressed air tools, FEIN battery packs and battery chargers) if you successfully complete the registration of your product purchase at www.fein.com within 4 weeks of the purchase date. You must print and retain your proof of registration as confirmation of your enrollment in the FEIN Plus Warranty program. Successful completion of registration will require you to provide all of the information requested and consent to the storage of your information pursuant to the privacy policy posted. Other than the term of coverage, all other terms and conditions of warranty service under our standard warranty as posted above will apply to the extended FEIN Plus Warranty program.

You are covered by our standard one year warranty regardless of whether or not you elect to register for extended coverage under the FEIN Plus Warranty program.
