LIFETIME LIMITED WARRANTY

This Limited Warranty (“Warranty”) applies to PEAK GLOBAL[®] LIFETIME[®] Antifreeze/ Coolant and PEAK GLOBAL[®] LIFETIME[®] 50/50 Prediluted Antifreeze/Coolant (individually and collectively, “PEAK GLOBAL LIFETIME” or “Product”) and includes all the terms and conditions stated below. This Warranty is free. No one may charge a fee for it.

PEAK GLOBAL LIFETIME features a patented, advanced Organic Acid Technology formula for use in the engines of all automobiles, light duty trucks and motorcycles regardless of make, model or year (the “Vehicle”). Old World Industries, LLC (“Old World”) warrants to the owner of the Vehicle (the “Vehicle Owner”) – for a period of *on-road* use as long as the Vehicle Owner owns the Vehicle (the “Warranty Period”) – that it will pay for the repair or replacement, at Old World’s option, of those parts of the Vehicle’s antifreeze or cooling system (the “A&C System”) that fail or show abnormal wear and tear from rust, corrosion or cavitation, as determined by Old World, as a direct result of using PEAK GLOBAL LIFETIME during the Warranty Period; provided that: (1) the Vehicle (including its A&C System) meets and was properly used and maintained in accordance with the Vehicle manufacturer’s specifications and recommendations (including initial and subsequent A&C System flush and fill requirements); (2) PEAK GLOBAL LIFETIME was installed, used and maintained (including an initial and complete A&C System flush and fill and subsequent topping off, as needed) in accordance with the Vehicle manufacturer’s specifications and recommendations and with Old World’s specifications and the directions on the Product label; (3) the Vehicle (including its A&C System) was used under normal operating conditions in accordance with the Vehicle manufacturer’s specifications and recommendations and with Old World’s specifications; (4) the Vehicle Owner maintains records verifying the condition set forth in items (1) through (3) above, including the PEAK GLOBAL LIFETIME sales receipt(s); and (5) the Vehicle Owner certifies continuous ownership and that no other products have been added to the PEAK GLOBAL LIFETIME Product. In no event will any claim payment (parts and labor) be made in an amount exceeding \$1,000.00.

PEAK LONG LIFE features an advanced Organic Acid Technology formula for use in the engines of all automobiles, light duty trucks and motorcycles regardless of make, model or year (the "Vehicle"). Old World Industries, LLC ("Old World") warrants to the owner of the Vehicle ("Vehicle Owner") – for a period of 150,000 MILES or 5 years of *on-road* use, whichever is earlier (the "Warranty Period") – that it will pay for the repair
