The warranty does not apply to repairs necessitated by damage, misuse, abuse or alteration and to any repairs of merchandise not used within the United States unless otherwise prescribed by law. Optimus Enterprise, Inc, shall not be liable for any personal injury, property damage or any incidental or consequential damages of any kind (including water damage) resulting from malfunctions, defects, misuse, improper installation or alternation of this product. This warranty is the only warranty extended by Optimus Enterprise, Inc, to its original customers and /or consumers purchasing fan, Optimus Enterprise, Inc, disclaims all other warranties, expressed or implied, that arise by the operation of law, specifically including the implied warranties of merchantability and fitness for a particular purpose.
