

## Battery Replacement

For best performance, we recommend replacing the batteries that came with this toy with three, new "AA" (LR6) alkaline batteries.



- Locate the battery compartment on the bottom of the toy.
- Loosen the screws in the battery compartment door and remove the door.
- Remove the exhausted batteries and dispose of them properly.
- Insert three, new "AA" (LR6) **alkaline** batteries.


**Hint:** We recommend **alkaline** batteries for longer battery life.

- Replace the battery compartment door and tighten the screws.
- If this product begins to operate erratically, you may need to reset the electronics. Slide the power/volume switch off then back on.
- When sounds and lights from this toy become faint or stop, it's time for an adult to change the batteries.



- Protect the environment by not disposing of this product with household waste (2002/96/EC). Check your local authority for recycling advice and facilities.


## Battery Safety Information



In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of this product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the product before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision

# Playful for daytime, soothing for bedtime!



- Slide the power/volume switch to ON with low volume or ON with high volume .
- Slide the mode switch to **Learning 123**, **Music** or **Night** mode.
  - 123 Learning** – Press the button to learn about opposites and hear fun sounds. Spin the roller for a song and dancing lights.
  - Music** – Press the button or spin the roller for soothing songs and tunes with dancing lights.
  - Night** – Press the button for a song and soft glowing light; spin the roller for sound effects and light.
- When you are finished playing with this toy, slide the power/volume switch OFF .
